I do understand that there is a small risk of potentially catastrophic injury or death by participating. I am aware of the risks and assume the responsibility associated with participation.
2. Recognizing the possibility of physical injury associated and in consideration for HIT SPORTS, LLC accepting the PARTICIPANT for its programs and activities (the "Activities"). I hereby release, discharge and or indemnify HIT SPORTS, LLC, its directors, coaches, sponsors, employees and associated personnel, including the facilities utilized for the Activities, against any claims, loss, damage or other disability.
3. HIT SPORTS, LLC, its employees or agents are not responsible for accidents and medical and dental expenses incurred as a result of participation in the Activities.
4. The PARTICIPANT is covered by family/personal insurance and is in good health and able to participate in the physical activity associated with the Activities at HIT SPORTS, LLC.
5. I GRANT PERMISSION to HIT SPORTS, LLC to use any and all images of the PARTICIPANT taken at their building or during any of their Activities on the website, social media or in any promotional material they see fit.
